Welcome to Central Bucks. You are registering your child in a district that is a leader in curriculum, instruction, assessment and staff development. Central Bucks is a suburban school district located in the heart of Bucks County, with administrative offices in Doylestown, the county seat.

In order to establish and verify your residence within the Central Bucks School District, an affidavit is required in addition to the required documents for admission. By filing this affidavit, the Central Bucks School District residents are declaring that they are allowing the non-resident child and their parent(s) or guardian(s) to reside in their home on a full-time basis. All procedures are in accordance with Sections 1301 and 1302 of the Pennsylvania School Code and Regulations 11.11 and 11.19 of the Pennsylvania State Board of Education. Sections 1301 and 1302 authorize Central Bucks School District to request proof of residence or guardianship prior to admission to our school programs.

Instructions for Completing the Attached Multiple Occupancy Affidavit

In an effort to clarify the Central Bucks School District policy concerning Multiple Occupancy requests, as well as to formalize your application, we ask that the Parent/Guardian AND the District Resident carefully read, sign and notarize the attached form. In addition to this form the following documents are required:

- The homeowner/lessee must provide three current proofs of residency showing the Central Bucks address at registration.
- The multiple occupant must provide three forms of identification showing the Central Bucks address within sixty days of registration.

Examples of these proofs are:

Homeowner/Lessee-

- Property Deed/Mortgage Statement/Agreement of Sale OR Lease Agreement
 AND two of the following
- Current utility bill
- Tax bill/receipt

Multiple Occupants

- Income tax verification at new address (local, state, federal)
- Employer notification of change of address and municipal tax deduction status if not self employed
- Vehicle registration including insurance policy/driver's license
- Credit card/car payment billing statement
- Government income verification (unemployment, public assistance/welfare, child support, alimony)
- Utility bill
- Legal Notices
- Medical billing statements
