## History

#### Early 1900's:

- The American eugenics movement advocated for the segregation of individuals with disabilities from the general public.
- Pennhurst State School is opened in 1908 (overcrowded conditions from outset)
- 1949: The Pennsylvania ARC founded to advocate for the needs of individuals with ID.
- 1965: Social Security Act Amendments establish Medicare/Medicaid

- 1966: Pennsylvania MH/MR Act authorizes services in community.
- 1968: "Suffer the Little Children"-Bill Baldini expose' of conditions at Pennhurst
- 1971: ARC vs. Commonwealth-Right to public education/due process
- 1977: Halderman v. Pennhurst-Found segregation of individuals in institutions unconstitutional.
- 1980's-1990's: Pennsylvania's ID/A HCBS waivers were first established
- 1980's-1990's Previous residents of Pennhurst begin process of receiving services in the community.

- 1990-Americans with Disabilities Act (ADA)-Equal access/reasonable accommodations
- 1990-Individuals with Disabilities Education Act-Free and appropriate education.
- 1999-U.S. Supreme Court Olmstead ruling-states must provide sufficient access to services in community settings

- 2015: Home and Community-Based Services (HCBS) Final Rule-Explains the qualities of HCBS settings and services
- 2016: Employment First Executive Order-First and preferred option for public supports
- 2016: Pennsylvania (ABLE) Act-Tax free savings accounts for disability related expenses


## Our Debt to Parents/Advocates of the Past

- Our sons/daughters enjoy many of the benefits fought for and won by parents and advocates of the past
- We have a responsibility to also continue fighting for the benefit of future generations of people with ID/A

### The Future of ID/A Funding

- The Medicaid Waiver programs are the lifeblood of the ID/A service system
- State-Federal partnership, w/ Federal matching of state funds
- No current limit to the Federal contribution
- Changes to the funding of these programs could have catastrophic ramifications for individuals with ID/A
- <u>Block Grant</u> or <u>Defined Budget</u> funding of Medicaid represents a serious threat to funding for HCBS
- Individuals & families need to be aware of conversations related to the funding of Medicaid & contact their representatives regarding potential changes to Medical Assistance funding





#### **Integrating array of supports**

"Historically, supporting people with disabilities revolved around the disability services system. But, truly it takes a variety of support to achieve a good life, not just the formal service system alone. Integrated supports include:

Our personal strengths, assets, and interests
Relationships that provide informal support
Community resources we access and count on
Technology
Eligibility-based supports (publicly or privately funded)"

### **Areas of Emphasis**

- Services in home and community-based settings
  - As opposed to settings that have the effect of segregating individuals from the general public
- Competitive integrated employment
- Communication
- Promoting individual choice
- Relationships
- Health & Safety/Freedom from Abuse

## Educational Classification vs. Program Eligibility

- Program Eligibility vs. Educational Classification
- Educational Classification
  - Entitlements based on condition
  - Impact upon education
- Program Eligibility
  - Standard for program participation
  - Not an entitlement
  - Qualifying program diagnosis
  - Degree of impairment
  - Available resources



Difference can confuse and frustrate parents

### **Eligibility Criteria**

- Intellectual Disability (ID)
- Significant impairments in intellectual functioning
  - Examples: WISC-V; WAIS-IV, CTONI, SB-V
  - 2 SD below the mean (i.e. FSIQ=70 or below)
  - Two or more areas of significant impairment in adaptive functioning (for registration)
  - Three of more areas of significant impairment in adaptive functioning (for waiver enrollment)
    - Vineland or ABAS-II/ABAS-III
    - 2 SD or greater below the mean (i.e. GAC or ABC of 70 or below)
  - Valid assessment results
  - Diagnosis of Intellectual Disability
    - Onset during developmental period (< to age of 22)



### **Eligibility Criteria**

- Autism Spectrum Disorder (ASD)
  - Diagnosis of Autism Spectrum Disorder
    - Informed by standardized diagnostic assessment (i.e. GARS, CARS, ADOS, etc.)
    - Three of more areas of significant impairment in adaptive functioning
      - Vineland or ABAS-II/ABAS-III
        - 2 SD or greater below the mean (i.e. GAC or ABC of 70 or below); or
        - 1 SD below the mean (i.e. GAC or ABC of 71-85), if the individual has a FSIQ of 85 or above.
    - Valid assessment results
    - Onset during developmental period (< to age of 22)</p>

### **Word of Caution**

- Eligibility cannot be reduced to simple numbers.
- Test results must be evaluated in the light of the entire record



#### **PUNS**

- While individuals may be found to be functionally eligible for waiver services, individuals are only enrolled based upon available openings (aka "slots".)
- The PUNS (*Prioritization of Urgency of Need for Services*) is the name of the 'waiting list' for ID/A services.
- Once enrolled in a waiver, an individual can access services
  - That they have an assessed need for (and)
  - Can be provided within an individual's given budget



## Transition Related Collaboration/Considerations

- Need to understand eligibility criteria for the ID/A system.
- Supports Coordinators participation in IEP meetings is essential
- Aligning IEPs post-secondary goals with post-graduation supports
- Can't overemphasize need to develop:
  - Independent living skills
  - Vocational related soft skills
  - Safety/alone time skills
- 24/7 supervision is exception in ID/A support system

### Sexual Health & Victimization

- People with intellectual/developmental disabilities are sexually assaulted at a rate more than seven times that for people without disabilities. Abused & Betrayed. National Public Radio (2018)
- Education regarding healthy relationships and sexuality is an essential tool
  in protecting individuals from victimization.

#### Sexual Health & Victimization

- The Bucks County Network of Victims Assistance (NOVA) provides Healthy Relationship training for children with intellectual/developmental disabilities.
  - Healthy boundaries
  - Guidelines for interpersonal interactions.
  - Personal boundaries
  - Appropriate and inappropriate touches and requests
  - Assertiveness skills
  - Public vs. private distinctions
- Individuals of all ages need age-appropriate sexual education and safety training
- Caregivers also need to be aware of the signs of victimization

## Bucks County Special Victims Investigation Program

- NOVA Special Victims Advisory Committee
- Sexual Assault Response Team (SART)
- CAC: systemic issues for adults with intellectual disabilities
- Vulnerable adults: challenges and obstacles in judicial system
- Encourage Arrest Grant (EAG): create protocols and guidelines for Bucks County (foundation for state standards)

### Bucks County Special Victims Investigation Program

- Goals of Program
  - Protect Vulnerable Populations
  - Reduce the Impact of Investigative Process
  - Advocate for Victims
  - Ensure Adequate Support Services
  - Hold Offenders Accountable
  - Prevent Future Victimization
