During this time when face to face gatherings have been suspended or cancelled ODP remains committed to providing information and training opportunities to Local Task Force participants. Please stay posted for more information about web versions to replace cancelled face to face sessions of ODP sponsored trainings and other gatherings.

**Operational Guidance for the ODP system in Response to COVID-19**

ODP submitted an Appendix K to the Centers for Medicare and Medicaid Services requesting temporary amendments to ODP's 1915(c) waivers. The purpose of the guidance is to support the ODP service system in adherence to the conditions of the emergency amendments approved in Appendix K and provide specific direction on process, documentation, and health and safety measures. Some examples of changes necessary include:

- The closure of all Community Participation Support facilities – all prevocational and day settings
- Some services can be now delivered remotely (including employment services)
- Some services can now be delivered by family members
- Supports Coordinators must check in with people more frequently to ensure they are healthy, safe and getting the help they need
- Some services can now be delivered in the hospital
- Supported Employment providers can now bill for assistance to individuals applying for and maintaining unemployment benefits

Training:

- 17% (7,223) of individuals (ages 18-64) enrolled with ODP are employed in competitive integrated employment (please note that due to lag time in data collection, we do not think this is an accurate representation of the impact on employment related to COVID-19.)
