- Research PA School code & laws governing voting map development
- Research other Bucks County and large PA districts' voting maps
- Have conversations with community members about the current map and the map approved by CBSD Board in November 2022
- Develop "Guiding Principles"
- Create a proposed map
- Share our proposal and collect petition signatures (>3600)

## CBSD Fair Votes Guiding Principles

## 01

Create regions as equal in population size as possible.

#### 02

Reflect the voter demographics of the district in each region.

#### 03


Increase the power of each voter by allowing them to vote every 2 years instead of every 4 years.

#### 04

Avoid voter disenfranchisement. Avoid impact on incumbent directors.




#### 4- Avoid voter disenfranchisement.

Fair Votes 3 region map does not change any voters' next election year.

A 3 Region Model eliminates the possibility of creating voter disenfranchisement by skipping voting years in future redistribution. Every voter will always have at least one director up for election every 2 years.



5-Avoid impact on incumbent directors.

•Signatures from a cross section of the electorate, Democrats, Republicans, and Independent voters from all 9 municipalities.
