Item 1-3 Revise note "Reset Electric Box To Match Proposed Pavement Elevation" to read "Existing Electric Box to be Removed. Contractor shall coordinate removal with Owner. Owner's Electrician will provide necessary electric work associated with removal."

- Item 1-6 All disturbed areas not receiving proposed improvements shall be seeded per Note 2 on Drawing L-103.





General Construction contract to include all labor, materials and equipment to construct improvements.
