Central Bucks School District School Board Brief May 15, 2025

At the May 15, 2025 School Board Meeting, the Central Bucks Board of School Directors:

Announced that the Board met with labor counsel in Executive Session on April 29, 2025, May 1, 2025 and May 12, 2025 regarding matters of personnel related to the ongoing investigation at Jamison Elementary.

Heard Superintendent's Report: President Gibson and Mr. Jaffe recognized and congratulated CB South 12th-grade student Faye Bader, this month's Portrait of a Graduate lock screen contest winner. Next, students from each of our high schools shared updates:

Landon Schea, junior at CB West, spoke about students named Academic All-Americans by the National High School Coaches Association, Delaware Valley Science Fair winners, Harlequin Club's Philadelphia's Independence Award and Bucks County Playhouse Festival nominations, Bucks County High School Poet of the Year, BCCC Short Fiction Contest, FCS students participating in the annual Feed My Starving Child drive, the senior prom and the annual Senior Sunset.

Avery Donahue, senior at CB East, spoke about OEG Club's modified "workout of the day" and push-up contest fundraisers that funded care packages for deployed military personnel, Memorial Day ceremonies at Wesley Enhanced Living, the VFW parade, and the track teams advancing to districts.

Amritha Sakamuri, junior at CB South, spoke about DECA Chapters, the Titan Thespian's Philadelphia Independence Award nomination, a toy drive and field day for students at Sheppard Elementary School, the Penn State science competition, a military recognition ceremony, and the junior and senior proms. Dr. Malone congratulated students Damon Baierschmidt, Blair Blake, Audrey Gaona, Dylan Hargrove, Sarah Maclean, Anna Nicotra, Brian File, Abhinav Medi, and Ivan Urquia for being selected to the Pennsylvania

Additionally, Blair Blake received first prize in the National Association of Music Education All-Eastern Composition Showcase, and Brian File was selected for the All-Eastern Festival.

Dr. Malone congratulated CB South teacher Frank Woodring and students Rita Moskowitz and Brooke Rosica of the CB South Operation Eternal Gratitude Club for applying for and being awarded a \$30,000.00 grant to help the club expand its work of providing care packages to active-duty military personnel overseas.

Dr. Malone and teacher Mark Hayden recognized and congratulated STEM Research students who took First Place in the Delaware Valley Science Fair: Aaditya Kambli, Prisha Parmar, Nilesh Pothirajan, Anna Ries, Snayhin Sharma, Soumil Sharma, Brianna Sisca, Anya Vijay, Sudhir Yelamarthy, and Dharunish Yugeswardeenoo. Mr. Hayden also recognized students who are competing in the Regeneron ISEF in Columbus Ohio right now: Prisha Parmer and Soumil Sharma.

Dr. Malone spoke about some of the items listed on tonight's agenda, including a funding contribution for a CBSD Education Foundation's EmpathED event, the 432.4 million dollar proposed 2025-2026 budget, an authorization to appeal the latest verdict in the equal pay lawsuit, and the 1,541 seniors who will graduate on June 11th.

Heard Public Comment about agenda items:

- 1. Evelyn Sanchez, CB student, spoke about students involved in the Harlequin Club at CB West and the need for space to store costumes, changing areas, and having restrooms located near the auditorium.
- 2. Dawn Marinello spoke about the equal pay lawsuit victory in Federal Court, an inaccurate email to the community sent by the CBSD board, and asked board members to vote "no" to the appeal authorization on the agenda.

- 3. Rebecca Cartee-Haring spoke about the equal pay lawsuit's jury finding that CBSD violated the EPA law twice, CB sending Dr. Zaleski to sit in at the trial, five years' of Discovery, and that the Board should compromise with the teachers who asked for a salary review.
- 4. Ed Mackouse spoke about the bullying policy, CB being an outstanding school district, automatic salary step increases for teachers, hiring being based on supply and demand, the definition of bullying, male National Merit Scholarship winners, and Title IX.
- 5. Art Larson spoke about taxes and about "Woke", tax increases in recent years, school districts getting into financial jeopardy, and said that the Board has a responsibility to not be propagandized and to stop raising taxes.

Heard Public Comment:

- 1. Michelle Crunkleton spoke about teenagers and sleep deprivation, statistics about the effects that sleep deprivation has on students, and said that later school start times should be part of the Comprehensive Plan.
- 2. Alyssa Marie spoke about her experience working in the autistic classroom at Jamison Elementary School. Alyssa Marie said that there was a consistent pattern of neglect, abuse, and mistreatment. Alyssa Marie spoke about accountability, standing up for children who cannot speak for themselves, and about her decision to speak out on November 14th.
- 3. Michael Henry asked why people are remaining silent and spoke about his child being subjected to abuse and neglect in the Jamison Elementary classroom, Dr. Yanni having deceived him, and that he wouldn't have known what happened if not for the whistleblower. Michael Henry asked how the Board can ensure that this never happens again and about having cameras in classrooms and said that anyone who enables abuse to happen should be gone from the district.
- 4. Maureen Sanchez spoke about having helped to raise money for organizations. Maureen Sanchez spoke about the Harlequin Club needing space in their school building. Maureen Sanchez spoke about CB West being the smallest high school and not having space to lose.
- 5. Ed Makouse spoke about having once been in the New York teachers union and that teachers' priorities should be their students, not money. Edward Mackouse spoke about the Board's priority being to hire the best teachers.
- 6. Mariann Davies spoke about the devasting reports regarding Jamison Elementary School that detailed the nature and severity of abuse, Dr. Garvin's retirement, and Board members who have remained silent.
- 7. Christina Bucci spoke about Advanced Placement courses, student mental health, and AP Capstone program and diplomas.
- 8. Donna O'Donnell spoke about her child being overlooked and neglected in the Jamison Elementary School classroom, not having been contacted by the Board, district, or school principal, covering-up for neglect, and the need to stand up for all children.
- 9. Vonna DeArmond spoke about the microphone volume, thanked the whistleblower for coming forward, asked why Dr. Garvin wasn't placed on leave along with the others who were placed on leave, spoke in support of Dr. Malone serving as substitute superintendent, and spoke about the equal pay lawsuit. Vonna DeArmond spoke about Rebecca Cartee-Haring and some Board members having said in the past that biological males who identify as women are women, and asked if those Board members and Rebecca Cartee-Haring would consider males who identify as women applicable to the EPA lawsuit.

Heard Board Comment:

Mr. Pepper said that there will be no criminal prosecution of the people who hurt our children by Jen Schorn or by Dave Sunday. Mr. Pepper spoke about our children having the same Constitutional rights, under the law, that we all have. Mr. Pepper spoke of disabled non-verbal children with autism not having equal protection under the law in this Commonwealth and County. Mr. Pepper spoke of there having been 2,933 illegal restraints used on his child from early September through December 20. Mr. Pepper asked United States Attorney for the Eastern District of Pennsylvania David Metcalf and asked United States Assistant Attorney General for the Civil Right Division head Harmeet Dhillon to open investigations into the violation of these children's Constitutional rights.

Mrs. Smith spoke about her suggestion to add an additional teacher to the Jamison Elementary classroom to ensure the safety of the students, which was acted upon. Mrs. Smith spoke about the nature of government work, and that decisions and action can take time. Mrs. Smith thanked people for their patience.
