Central Bucks School District School Board Briefs November 12, 2024

At the November 12, 2024 School Board Meeting, the Central Bucks Board of School Directors:

Announced that the board met in Executive Session this evening, November 12, 2024, prior to the school board meeting regarding personnel and legal matters.

Heard Superintendent's Report:

A. Recognitions: Dr. Yanni recognized CB West student Kayla Sanocki for her original design for the November lock screen contest. Kayla's artwork was based on this month's Portrait of a Graduate attribute "Effective Communicators".

Dr. Yanni recognized Cold Spring Elementary School teacher Katie Cuerou who recently administered the Heimlich maneuver to a student who was choking during snack time.

- **B. Remarks:** Dr. Yanni spoke about the six CBSD schools that will pioneer full-day kindergarten next year: Cold Spring, Doyle, Groveland, Jamison, Kutz, and Mill Creek.
- Dr. Yanni shared updates to the district calendar: Class of 2025 graduation ceremonies will be held on June 11, and June 11, 12, and 13 will be early dismissal days.
- Dr. Yanni spoke about retiring School Board Policy 123.3; the current (suspended) policy 123.3 has some conflict with current law and spoke about how our policies should grounded in law and in statute.
- Dr. Yanni spoke about School Board Policy 903; proposed language includes having two periods of public comment at school board meetings. The first period pertaining to agenda topics and the second period pertaining to any topic. CBSD students will always be offered time to speak during the first period of public comment without regard to the topics they wish to address.
- Dr. Yanni spoke about the appointment of solicitors: Wisler Pearlstine, LLP for district solicitor, and Clarke, Gallagher, Barbiero, Amuso, & Glassman Law for labor relations and tax matters. Ed Diasio and Peter Amuso will be the district's primary solicitors from each firm.
- Dr. Yanni spoke about the PSSM Belonging Survey that was presented to staff and to students in grades 5-
- 12. The survey questions are posted to our website.

- 8.) Christian Bucci, Chalfont Borough, spoke about early kindergarten admission, IQ scores, and gifted instruction.

- 9.) Mara Witsen, Chalfont Borough, spoke about School Board Policy 123.3 and yielded her remaining speaking time to Vonna DeArmond.
- 10.) Vonna DeArmond, Plumstead Township, spoke about a law firm on the agenda and a potential conflict of interest for Dr. Yanni, our district being sanctioned, politicians and solicitors, School Board Policy 123.3, the Board ignoring data regarding males and females in sports, and spoke about a social media post made by Mrs. Reynolds.
