## Heard the Superintendent's Reports:

Facilities, Energy Management, and Operations Director Robert Kleimenhagen, Jr. informed the Board and the public that the FEMO Department has been working diligently on cleaning and disinfection throughout all buildings. Each day, high-touch areas are disinfected throughout the day and again at nighttime. Mr. Kleimenhagen also provided an update on the work at Central Bucks High School West, which included the replacement of pipe insulation, indoor air quality testing throughout the building, and added that air quality reports can be viewed on the Central Bucks West website.

Assistant Superintendent for Elementary Education Dr. Nadine Garvin informed the Board and the public that Kindergarten - Grade 6 conferences will be held December 10th and 11th, and additional Kindergarten will be held December 14th and 15<sup>th</sup>.

Superintendent Dr. John Kopicki informed the Board and the public that as of today there have been 159 positive cases of COVID in our district, of which 20 were virtual students. Dr. Kopicki shared that he speaks daily with CBSD Pandemic Coordinator/Student Services Director Dr. Cheryl Leatherbarrow to receive positive-case updates. Dr. Kopicki shared that the Attestation form was sent to the state, and we are in sync with the new guidelines. Dr. Kopicki shared that our district website's page that includes COVID cases is constantly updated and can be accessed by a link on the homepage. Dr. Kopicki shared that BCIU Executive Director Dr. Hoffman has been tremendous in keeping us informed, advocating for us, communicating with the state, and is an outstanding resource for Superintendents. In answer to a question from School Director Gamble, Dr. Kopicki stated that we believe that what we release about classroom exposure is appropriate. School Director Smith stated that she believes that we should return to virtual instruction due to the recent surge in COVID cases in order to keep our students, staff, their families and the community as a whole safe.
