# Central Bucks School District School Board Briefs May 14, 2024

At the May 14, 2024 School Board Meeting, the Central Bucks Board of School Directors:

**Joined** Groveland Elementary School students in the Pledge of Allegiance: Groveland Elementary School music teacher Steve Reilley, principal Kelly Carter, and assistant principal Christie Corcoran joined students Madison, Regan, Brianna, Kenna, and Josie. Regan, Brianna, Kenna, and Josie signed the National Anthem using sign language. Madison sang the National Anthem. Next, all five students led the Pledge of Allegiance.

**Announced** that the Board met in Executive Session prior to this evening's meeting, May 14, 2024, regarding personnel and legal matters.

**Heard** Superintendent's Report: Dr. Scanlon announced that this month is Asian American, Native Hawaiian, and Pacific Islander Month. In the month of May, our nation reflects upon and celebrates the role that Asian Americans, Native Hawaiians, and Pacific Islanders have made in American history. This year's theme is "Bridging Histories, Shaping our Future".

Dr. Scanlon announced that the month of May is also Jewish American Heritage Month. Each May, organizations and Americans of all backgrounds join to celebrate and pay tribute to the many contributions that generations of Jewish Americans have made, and continue to make, to our nation's culture, history, government, and society.

Dr. Scanlon announced that Lenape Middle School students Rory Dee and Nikita Chezryakov were award winners at the 2024 Mordechai Anielewicz Creative Arts Competition. Named in memory of the heroic young leader who organized Jewish resistance and gave his life fighting in the Warsaw Ghetto Uprising of 1943, the Mordechai Anielewicz Creative Arts Competition invites students in grades 7 - 12 to learn about the Holocaust and respond by means of creative expression. Students may submit original works in the form of poetry, prose, drawing, painting, sculpture, music, dance, and video. Artwork will be exhibited onsite at Gratz College in the Kramer Gallery. Nikita Chezryakov won Third Place in the Art category and Rory Dee won First Place in the Art category for her artwork titled "Bones and Bars".

Dr. Scanlon announced that Solution Tree recently recognized CB East as a "Promising Professional Learning Community at Work". Solution Tree recognizes schools whose educators focus on learning and building a collaborative culture.

Dr. Scanlon announced that CB West senior Sarah Ladley received McDaniel College's highest academic honor, a Dorsey Scholarship. Sarah's scholarship includes full tuition, room, and board for all four years, valued at over \$250,000.00.

Dr. Scanlon and President Smith recognized student achievements in STEM research. Mr. Mark Hayden, who serves as the instructor and research adviser for our Biotechnology Partnership Program, shared each project title and called each of the following students forward to receive a Certificate of Recognition:

## **Heard** Public Comment:

- 1. Mary Ayata, CB student, spoke about the CB West MSA Club, harassment by outside adults, mistakes of the past Board, and restrictions on speech.
- 2. Salman Benjelloun, CB student, spoke about the CB West MSA Club, the MSA and JSU Clubs standing together, not restricting student voices, and the Board supporting students.
- 3. Maen Alfeen, CB student, welcomed Dr. Yanni to CBSD and spoke about the interfaith collaboration between the MSA and JSU Clubs, not changing policies, and outside adults preying on children.

- 4. Egot Sakhabutdinov, CB student, spoke about the interfaith event hosted by the MSA and JSU Clubs, outside adults spreading lies, and the current Board protecting students.
- 5. Semyon Sakhabutdinov, CB student, spoke about policy revisions being unnecessary, a recent collaboration between school clubs, and outside adults trying to divide people.
- 6. Jenny Zhang, Buckingham Township, spoke about protecting students, building a welcoming learning environment, and protecting First Amendment rights.
- 7. Durriya Shamsi, Buckingham Township, spoke about Muslim students and community feeling under attack, standing against extremists, and ensuring the policies don't restrict student voices.
- 8. Marwa Ablad, Chalfont Borough, was listed on the sign-up sheet but did not speak.
- 9. Shannon Harris, parent, spoke about executive sessions, Solicitor Conn, Sunshine Act violations, and read aloud from emails she obtained through Right to Know.
- 10. Doreen Stratton, Doylestown Borough, congratulated the students who were honored tonight and spoke about facilitator exercises that she was once a part of.
- 11. Mike Sobczak, Plumstead Township, spoke about actions and consequences, Policy 903, enforcing a policy disallowing people from outside the community speaking at our meetings, and Mrs. Gibson trying to control the policy meeting.
- 12. Einav Mizrachi, Warwick Township, spoke about her children's safety in school, Mr. A., Dr. Scanlon's contact with the media, and a teacher sending a private message to his son.
- 13. Shylev Mizrachi, Warwick Township, spoke about being blocked from the MSA Club Instagram account and a post that his teacher made.
- 14. Inna Pyatesky, Buckingham Township, spoke about the Holocaust, the MSA Club, a teacher's personal account, Dr. Mahmud's recent board meeting comments, school club social media accounts, and updating and enforcing policies.
- 15. Fania Karlitsky, Warrington Township, spoke about school clubs, social media, and school board policies that are in existence.
- 16. Areej Alfeen, New Britain Township, spoke about some of her experiences when in school, EID being added to the school holiday calendar, and having more collaborative school club events.
- 17. Mara Witsen, Chalfont Borough, spoke about Israeli Independence Day, policies that protect students, making policy changes, and comments that Dr. Mahmud made at a previous meeting.
- 18. Art Larson, Doylestown, spoke about the No Place for Hate Program, crime syndicates, the Anti-Defamation League, and the mafia.
