Central Bucks School District School Board Briefs September 10, 2024

At the September 10, 2024 School Board Meeting, the Central Bucks Board of School Directors:

Announced that the Board met in Executive Session on Thursday, July 25, 2024 regarding the equal pay lawsuit, case number 20-1995-21-2587.

Heard Public Comment:

1. Ed Mackouse, Buckingham Township, spoke about the meeting format for candidate interviews and about each candidate. Mr. Mackouse shared his support of board candidate Elana Abrams-Sudai. Mr. Mackouse spoke about Covid, vaccines, Twitter posts, autism rates, and links between autism and vaccinations.

2. Kirsten McGowen, Buckingham Township, spoke about no-phone policies in schools, smart phone use by children, and the "Wait Until 8th" pledge.

3. Jamie Walker, Chalfont Borough, yielded her speaking time to Vonna DeArmond.

4. Vonna DeArmond, Plumstead Township, spoke about Mr. Haring missing two meetings. Ms. DeArmond read aloud part of policy regarding removal from the board after missing meetings. Ms. DeArmond spoke about the board candidates, posts on Twitter, Sunshine Act violations, Right to Know emails, Solicitor Conn, board training, and asked Mrs. Smith to resign.

5. Mara Witsen, Chalfont Borough, asked if the board did a google search on the board candidates and spoke about Mr. Haring's meeting attendance.

6. Art Larson, Doylestown Township, spoke about gangster government, the Philadelphia Inquirer, national crime and Anenberg syndicates, the ADL, and his offer to help COO Houser with the district's budget. Mr. Larson provided a handout.

7. Angelo Menta, Doylestown Borough, spoke about our support staff, advertising to increase staff, shared some hourly rates from other districts, and about prioritizing the hiring of PCAs and EAs.

8. Shannon Harris, parent, recommended appointing one of the two Republican candidates for the vacant board seat and asked why Solicitor Conn is in attendance. Ms. Harris read aloud some emails obtained through a Right to Know request and presented a handout.

9. Christina Bucci, Chalfont Borough, spoke about early admission to kindergarten, read aloud part of policy 201, and about other Pennsylvania school districts that allow early admission.

10. Carla Grabianowski, Plumstead Township, was listed on the sign-up sheet but did not speak.
