*Valerie Berkobin of Doylestown* addressed the Board regarding systemic racism, implicit bias, anti-racism, equity, and diversity in school curriculum, and teaching the history of this country, the Constitution, the Bill of Rights, the proper use of the English language, and a working knowledge of math and science.

Jamie Walker of New Britain addressed the Board regarding the COVID resolution, the Health and Safety Plan, instructional models, face masks, children wearing face masks while playing sports, the metrics to open schools, modified quarantine, a district lawsuit, the Office of Open Records, district legal expenses, and transparency.
